## SPORTS YOGA® TRAINING PROGRAM PURCHASE GENERAL TERMS & CONDITIONS

These terms and conditions apply to all transactions on this site. Please read them carefully. You will be asked to accept the terms and conditions when you place an order. We recommend that you print a copy of these terms and conditions for your future reference, or that you download them. You will acknowledge that you have read, understood and agreed to be bound by these General Terms & Conditions.

- 1. Course expires from the date learning material has been delivered to the student.
- <u>Applicants have 3 days from the date of purchase</u> to cancel their order. At the end of 3 days term NO REFUND APPLY under any circumstances. Cancellations are <u>only</u> accepted in writing (by email).
- 3. Fees are inclusive of \$ 70 non-refundable administration fee.
- 4. Fees are refunded MINUS \$ 70 non-refundable administration fee.
- 5. No refund apply under any circumstances for correspondence courses after the Learning Material have been delivered.
- 6. PayPal transactions (3% surcharge apply).Bank Transfer save \$25.
- 7. Training Manual including Certificate of completion is dispatched in PDF format (colour-printable) delivered via secure server. No **Hard Copy** available.
- Important Notice: Applicants are required to provide a valid email address. We only dispatch 1 copy of the Training Manual. If the material is NOT received due to the recipient's inaccurate or invalid email address, to receive another copy \$70 charges apply.
- 9. If the course is not completed by the due date, extensions are available at \$20 charges per extra week.
- 10. Applicants are required to pay 10 weeks (\$ 20 per week) \$ 200 **refundable deposit** in advance for course extensions, the deposit is included in the fee. Deposit for extensions will be refunded upon course completion MINUS any used extensions.
- 11. Extensions charges apply from the course certification expiry date until we receive cancellation as stated on the order.
- 12. Fees does NOT include theory test <u>re-sits</u>. Students that fail the first attempt must pay \$55 for the second re-take.
- 13. If the student fail the second theory test attempt he/her will be tested online by one of our Assessor via Skype.
- 14. The Freelance Instructor Licence (24 months) is included in the fee.
- 15. Fee includes all the following:
  - (a) SPORTS YOGA® Training Manual;
  - (b) 24 months Freelance Sports Yoga® Instructor Licence and a FREE Sports Yoga® Demo DVD;
  - (c) 1 online theory test with live invigilator;
  - (d) \$ 200 refundable deposit course extensions;
  - (e) Certificate of completion and registration which entitle certified instructors to appear on the International Sports Yoga® Worldwide Registry and on Yoga Alliance International Registry
  - (f) Fitness Australia CECs certificate (continuing education certificate for Fitness Professionals ONLY).
- 16. Students that fail the Theory Tests will NOT be issued the Certificate of Completion or the Sports Yoga® Freelance Licence until they fully met the Certification requirements. Online Theory test timeframe: 30minutes.
- 17. Upon receiving the Enrolment Form and payment confirmation, the SPORTS YOGA® legal team will send the Freelance Instructor Licence to the applicant.

- 18. In order to release the course learning material, the Licence must first be returned to us duly signed by the applicant.
- 19. The Licence validity commence from the date the applicant successfully obtained certification, read more: Sports Yoga® Licence Information
- 20. Sportsyogaworldwide owns the Intellectual Property in the Sports Yoga® Program and the Trade Mark Registered in Australia and International Jurisdictions and in certain Materials it publishes concerning the Sports Yoga® Program.
- 21. Allow 15 working days for refund to be received.
- 22. PAYMENTS not accompanied by the Enrolment Form and proof of purchase are returned to the recipient within 15 working days from the date received minus \$ 50 administrative fee.
- 23. Applicants must be over the age of 18 years to apply for Sports Yoga®.
- 24. It is 'mandatory' at the time of enrolment to provide <u>copy of two current ID</u> (colour Not b&w) **Driver Licence and Passport.** These two ID are required to verify the identity of the person enrolled on the course when sitting the online web cam theory tests with live invigilator and to purchase the SPORTS YOGA ® Licence which is a legally binding document.
- 25. Without two Form of ID showing high quality colour photo of the applicant, the Application will NOT be considered.
- 26. Orders are process within 5 working days from receiving the payment which must be accompanied by the Enrolment Application Form.
- 27. Request for course extensions must be notified <u>by email three weeks</u> prior the course expiry date. \*Due to negligence\* of some students in the past, failure to comply with extensions procedure will result in a <u>\$40 penalty fee</u> which will be deducted from the extensions deposit.
- 28. **Important Notice:** At the end of the course students are required to submit videoed practical exam and complete the online theory test. Pass Mark 85% is required in both components to receive Certificate of completion.
